

Falls for Cash



TOURNAMENT RULES

1. Individuals nineteen (19) years of age or older are eligible to enter except Officers, Directors or Employees of Fallsview Casino Resort, Casino Niagara, the Falls Management Company, Falls Management Group, L.P., its Affiliates, Complex Services Inc., the Alcohol and Gaming Commission of Ontario, or key employees of the Ontario Lottery and Gaming Corporation.
2. Participants must present valid government issued photo identification on request.
3. Notwithstanding paragraph 1, Fallsview Casino Resort reserves the right to deny an applicant or reject a participant, once accepted, for any reason which, in its sole judgment and discretion, it deems proper, as authorized by law.
4. Entry fee is two hundred and fifty (\$250) dollars in Canadian Currency.
5. Fallsview Casino Resort reserves the right to cancel or alter the Falls for Cash Slot Tournament (the "Tournament") for any reason on or before the tournament date. If canceled, all participants will be notified, entry fees (\$250) will be returned, and neither party shall have further liability to the other.
6. Participants may cancel their enrollment in the tournament up to seven (7) days before the tournament. Failure to provide seven (7) days prior notice will result in forfeiture of the entry fee.
7. Participants can only enter once on each tournament date.
8. All registered participants should report to the tournament area no later than fifteen (15) minutes before their scheduled session time.
9. Players Advantage Cards will not earn any points during tournament play.
10. Persons playing in sessions must be registered and qualified participants. Fallsview Casino Resort may, however, allow registered participants to give their place to a substitute participant.
11. Any participants wishing to substitute a guest into the tournament must fill out a Substitution Form in full and submit it to the Tournament Official before their session time.
12. Substitute players are not eligible to win the tournament prizes. Prizes will be issued to the registered and qualified participant. Substitute players must be Players Advantage Club members.
13. The sixty thousand (\$60,000) Canadian dollar cash & prize purse is based on full occupancy of two hundred (200) registered entrants. The prize purse will be based on complete registration and may be adjusted accordingly.
14. Each participant will play in two (2) tournament sessions. The score from each of the tournament sessions will be combined to determine the top 50 scores (plus ties).
15. Participants who miss a session or arrive late may forfeit their session and receive zero points for that session.
16. The Tournament Participants will be assigned machines and session times during registration.
17. Each session will have a playtime of fifteen (15) minutes with four hundred twenty (420) credits on the credit meter.
18. A participant may only begin to play his/her machine upon the direction of the tournament announcer.
19. If a machine malfunctions, a Fallsview Casino Resort Slot Technician will attempt to correct the problem so that the participant can continue to play on the assigned machine. If a machine cannot be repaired in a short period of time, the participant will be moved to an alternate machine. If the participant is not able to complete his/her session on the alternate machine, the participant will be assigned to a subsequent session.
20. Each participant must sign a score sheet after each session played. By signing the score sheet, the participant agrees to their session score. (A participant's failure to sign their score sheet will result in the participant relinquishing the score confirmation to the scorekeeper and tournament coordinator).
21. The score recorded on the score sheet is based on the score that is registered on the slot machine's win meter.
22. The cash purse will be divided between the top fifty (50) winners (plus ties) based on their cumulated scores.
23. In the event of a tie between two (2) or more participants with the same score, the tied cash prize as well as the next ranked prize will be split equally between the participants involved, as per the place they finished within the tournaments cash prize structure. If there is no next ranked prize, the minimum prize is \$250 per player. The actual monetary value of the cash prizes paid per place of finish is directly dependent on the number of participants with the same score, if any.
24. All tournament prizes will be awarded at the end of the tournament at Fallsview Casino Resort Grand Hall E. Cash prizes will be awarded in Canadian currency. Winners not present will have ninety (90) days to claim their prize at any cage at Fallsview Casino Resort, or that prize will be forfeited.
25. Any dispute that may arise during tournament play must be submitted immediately to a Fallsview Casino Resort Tournament Official whose decision will be final.
26. The participant agrees to abide by all tournament rules as published or amended.
